- 1. No puril shall be refused admission on account of his caste creed or inligion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste creed or religion.
- . 2. No pupil shall be complled to attend a class in which a relig--ious instruction is given or take part in any religious exercises.
 - 3. The school with its account books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Department, Executive Officers of the Govt. authorised to inspect schools and Health Officer deputed by the Health Department to examine the health of the students or sanitory condition of the building and premises.
 - 4. The schools shall have to furnish all information and returns as called for by the Department from time to time.
 - 5. The school shall comply with the rules of the Department and directions as given by the department so far as they are applicable to private schools in the interest of maintaining education standard. The Director of Education shall have the authority to send any of his officer for inspection for proper maintenance of educational standards, holiday as per State Govt.etc.
 - 6. The school staff and students shall not take part in any agitat-ion directed against the authority of Govt. or dismeminate
 coinions tanding to excite feelings of disloyalty or dissovertion against the Covt. or of entity and hatred between different
 communities.
